As a result, digital evidence is often overlooked, collected incorrectly, and analyzed ineffectively. The aim of this book is to educate students and professionals and personnel of investigation agencies in the law enforcement, forensic science, computer security, and legal communities about digital evidence and computer crime. This book offers a comprehensive and integrative introduction of e-discovery evidence of digital forensics.
